

Terms & Conditions

- 1. All the minor maintenance responsibilities, adherence to park rules and regulations, liability clauses, and any applicable fees or charges I,e. Rs.5/- per ticket. The owner is usually responsible for ensuring compliance with local laws, maintaining the condition of the property, and respecting other users' rights.
- 2. All equipment and plants within the park are maintained exclusively by the owner, ensuring proper upkeep and safety. Visitors are expected to adhere to park rules, refrain from damaging or altering any equipment or plants, and use the facilities responsibly. The owner is not responsible for any injuries, damages, or losses incurred during park visits, and visitors access the park at their own risk. Additionally, any misuse or neglect of the equipment or plants may result in restrictions or termination of access, and the owner reserves the right to make changes to the park's operations as needed.
- 3. if any additional Park items are installed by the owner within the designated period, these items will be handed over to the owner, implying ownership transfer or custody rights. This clause ensures clarity regarding ownership of extra installations made during the agreed timeframe, and likely emphasizes that such additions must comply with park regulations and may require prior approval. For comprehensive understanding, it is advisable to review the complete agreement document, as additional conditions regarding maintenance, liability, or restrictions may also apply. After agreement period owner may take over all equipments installed by him/her, but it shall not destroy the ground situation of park.



- 4. By entering, guests agree to follow all posted rules and regulations, including adherence to opening hours from 6:00 AM to 11:00 AM & 3.00PM to 8.00 PM. Please supervise children at all times, refrain from bringing outside food or beverages, and respect the park's facilities and other visitors. Smoking, alcohol, and disruptive behavior are strictly prohibited. The park reserves the right to refuse entry or ask visitors to leave in case of non-compliance. For safety reasons, certain rides or activities may be temporarily unavailable without prior notice
- 5. The quotationer will have to submit, Tender paper cost, valid PAN , GST and Registration certificate (if any) along with the quotation.
- 6. Tender paper and submitted documents should be signed in each paper by the tenderer
- 7. Corrigendum, if any, published, would appear only on the Office Notice Board and www.nilgirinac.in.
- <u>8.</u> Incomplete quotations, quotations received without paper cost and quotation received after the stipulated time shall out rightly be rejected.
- 9. Conditional tender will be rejected immediately after opening of the same during evaluation. The rates should be written clearly and legibly without any error or overwriting and both in figures and words.
